### **Routes to the Test**

**From the Roberts Center**, head southwest on Gano Rd toward US-68 (0.2 miles) Turn left onto US – 68 S ( 4 miles). Use the left lane to take the OH – 73 exit toward Hillsboro (3.3 miles). Use the right lane to take the US-22/OH-3 ramp to Washington C H / Wilmington (0.3 miles). Turn left onto OH-3 N / US-22 E (3.5 miles). Turn right onto Cherrybend Road (2.2 miles). Arrive at 2326 Cherrybend Road, Wilmington Ohio 45177.

### **From Cincinnati (coming from South or West)**

Get on I-71 N 3 min (0.7 mi). Follow I-71 N to OH-73 E in Chester Township. Take exit 45 from I-71 N 39 min (43.5 mi). Continue on OH-73 E. Drive to Cherrybend Rd in Richland Township 18 min (15.3 mi). Arrive at 2326 Cherrybend Rd. Wilmington, OH 45177

### **From Columbus (coming from North or East)**

Get on I-70 W/I-71 S 4 min (0.9 mi). Follow I-71 S to OH-72 S in Jefferson Township. Take exit 58 from I-71 S 43 min (48.8 mi). Continue on OH-72 S. Drive to Cherrybend Rd in Richland Township 13 min (10.7 mi). Arrive at 2326 Cherrybend Rd. Wilmington, OH 45177
